## **Information about data processing at LOHKE Materieludlejning as**

As part of the conclusion of an agreement to become a customer at LOHKE Materieludlejning as, Hammerholmen 43-45, 2650 Hvidovre, tel. 70 20 62 42, CVR: 29 41 67 96, as so-called data controller, treats a number of common personal data (name, address, e-mail, etc.) regarding you.

The treatment is carried out in accordance with Article 6, Paragraph 1, litra b of the General Data Protection Regulation. In addition, processing is carried out in accordance with Article 6, Paragraph 1, litra f, as treatment is necessary. At the creation of the account, we can ask for identification in the form of a health insurance card and driving license on the person who creates the account. We cover up the last four digits of the CPR number so that only the birthday is processed and stored.

Your personal information will be disclosed to our debt collection company in case of non-payment.

LOHKE Materieludlejning as does not transfer your personal information to third countries or international organizations.

LOHKE Materieludlejning as will keep your personal information as long as you are an active customer with us. Personal data will be deleted no later than 5 years after termination of customer relationships.

We notify you that you have the following rights under the General Data Protection Regulation in relation to the personal data that LOHKE Materieludlejning as process about you:

- The right to insight.
- The right to request rectification or deletion.
- The right to request limitation of treatment and to object to such treatment.

You have the opportunity to file a complaint with Datatilsynet, Borgergade 28, 5, 1300 Copenhagen K if you believe that LOHKE Materieludlejning as does not process your personal information in accordance with data protection rules.
